Minutes of 03/11/19
Regular Council Meeting

CALLED TO ORDER:

Mayor David Jansing opened the council meeting of Lakeside Park City Council at 7:00 p.m. on Monday, March 11, 2019, in the City Building, located at 9 Buttermilk Pike. Mr. Gastright led the pledge to the flag and followed with a prayer. Those in attendance were Mayor Jansing, Council Members; Mr. Gastright, Mr. Bernheimer, Mr. Markgraf, Mr. Stegman and Mr. Waite. Mr. Disken was absent. Also present were City Attorney Mr. Voss and Deputy City Clerk Mrs. Hehman.

AGENDA:

Mr. Stegman made the motion to adopt the agenda as presented. Mr. Gastright seconded the motion. Voice vote was taken. 5 Ayes, 0 Nays, 1 Absent. Motion carried.

MINUTES:

Council having received copies of the 2/06/19 Special Meeting minutes was asked for any additions or corrections. Mr. Waite made the motion to adopt the minutes as submitted. Mr. Stegman seconded the motion. Voice vote was taken. 5 Ayes, 0 Nays, 1 Absent Motion carried.

Council having received copies of the 2/11/19 Regular Council Meeting minutes was asked for any additions or corrections. Mr. Bernheimer made the motion to adopt the minutes as submitted. Mr. Markgraf seconded the motion. Voice vote was taken. 5 Ayes, 0 Nays, 1 Absent. Motion carried.

MAYOR'S REPORT:

The Mayor's Group Meeting will be hosted by the City of Ryland Heights on March 16th. The meeting will begin at 9 a.m. All members of council are welcome to attend the meeting. Mayor Jansing reported there will be a Building Committee Meeting on March 14th at the City Building to meet with the lowest bidder and review the bid and see if there is any way to reduce the cost.

LEGAL:

Mr. Voss stated the Zumbiel case is moving forward and they will set dates for depositions. He received 7 delinquent tax bills to file a lien on each property.

CITY CLERK/TREASURER'S REPORT:

Ms. Davis turned over all remaining property tax bills to the City Attorney.

PUBLIC WORKS:

Mr. Stegman reported the Turkeyfoot Road Sidewalk Project has wrapped up. The city is waiting to receive reimbursement from the County. The remaining yard restorations will take place this spring. The Hudson Avenue Project will wrap up this year with the roadway construction from Cahill to Dixie. SD1 has completed their portion of the project. The Carran Drive Reconstruction has been completed and JPS will return to complete any yard restoration once the weather breaks.

POLICE AUTHORITY:

Mr. Markgraf reported the department participated in the Kenton County Government Citizens Academy. A presentation was given to Covington Catholic about cyber safety and real world safety. Several Active Threat classes were taught. The cruiser was sold at auction and the proceeds will be used to outfit the new cruiser.

Chief Schutte gave an overview of the annual report.

FIRE/EMS:

Mayor Jansing reported that there will be a volunteer appreciation night on March 12th and will honor the Volunteer of the Year.




